### **Processing of data**

We receive and retain information about you, such as:

We collect the information you provide to us, including:

- Your name, e-mail address, address and / or zip code, payment methods (bank account number) and telephone number.
- Data is collected when you create an account, make account changes, subscribe to a platform, and access customer service.
- Data that you communicate to us.

## Sharing data with third parties

- **Promotional offers:** we can offer joint promotions or giveaways to which you can only participate if we share your data with third parties. - **Mergers and acquisitions:** in connection with reorganizations, restructurings, mergers, sales or other transfers of assets, we transfer data, including personal data, on condition that the receiving party agrees to respect your personal data in accordance with our Privacy Policy.
